Thank you for providing a foster home. Your help in saving an animal's life is greatly appreciated by all of the humans and animals who are part of our Rescue. We wish you a very rewarding experience. The following list describes our expectations for providing foster care for a rescued animal so that you and the animal you are fostering will get the most out of your time together.

- ❖ Cats will remain indoors at all times. Cats will not be exposed to any cats who go outdoors.
- ❖ Dogs will be indoors or confined to a safe, well-protected and fenced yard. Dogs will be leashed at all times outside of the yard and will not be tethered in the yard. A proper exercise regimen will be followed as instructed by the foster coordinator.
- ❖ Any food, litter, or supplies needed will be communicated to the foster coordinator.
- ❖ Vet care will be provided only by an authorized veterinarian that is pre-approved by a representative of Indigo Rescue. Medication will be administered as instructed by the veterinarian. Additional supplements will be administered as instructed by the foster coordinator.
- ❖ If, at any time, you, a family member (including pets) or the foster animal is unhappy with the situation, you will contact a volunteer immediately to pick up the animal as soon as can be arranged. (Please do not adopt out, temporarily house or board any animal without speaking to the foster coordinator.)
- ❖ All fostered animals are the property of the Rescue unless otherwise arranged in writing. If you decide you are interested in adopting the animal you are fostering, the foster coordinator can provide you with an adoption application for consideration as with any adoption. The process and adoption fees for foster parents are the same as they are for adopters.

Indigo Rescue Foster Agreement – Hold Harmless Waiver

The following is the standard Indigo Rescue Foster Agreement that is required to be signed by all Fosters during the Fostering process. In consideration of receiving the animal described herein from Indigo Rescue, Foster _____, a person of the full age of majority and of full capacity to enter into this agreement, agrees to be bound by the following terms and conditions (herein referred to in global as "Agreement"):

I. GENERAL CONDITIONS AND WARRANTY OF FOSTER Foster will provide proper and sufficient food, water and shelter, and warrants that he/she will provide kind and careful treatment to the animal at all times. Foster assumes full responsibility for this animal for the animal's entire stay in Foster's home, and fully understands that Indigo Rescue is placing this animal in Foster on this condition. Foster shall not leave the animal unsupervised outside. Foster

shall not chain, leash or otherwise tether the animal to any object, indoors or outdoors. All dogs require training or housebreaking to prevent chewing and permit time for adjustment to family and other pets. Foster acknowledges and fully accepts responsibility to provide proper and humane training.

II. MEDICAL CARE OF THE ANIMAL a. All animals are spayed and neutered prior to adoption from Indigo Rescue. b. Foster will take the animal to a veterinarian for examinations and scheduled immunizations on request by Indigo Rescue representative (minimum legal requirement of rabies), and will contact Indigo Rescue for immediate authorization for veterinary care from an authorized Indigo Rescue veterinarian should the animal become ill or injured. Indigo Rescue will not reimburse Foster for vaccinations, surgeries or any other services provided by any other than authorized veterinarian.

III. CONDITIONS OF FOSTERING A RESCUE FROM INDIGO RESCUE a. Foster will not give the animal to any other person or business. Foster agrees to make an appointment with Indigo Rescue for the return of the animal, should an emergency arise that prohibits Foster from continuing to keep the animal. A reasonable amount of time must be allowed for Indigo Rescue to make arrangements to move the animal into a different Foster home. b. Foster agrees that if Foster has taken more than one animal from Indigo Rescue for Fostering at the same time, the animals will reside together for their entire stay in Foster's home. Foster must obtain written approval from Indigo Rescue to separate the animals. However, Foster understands that it is highly unlikely that Indigo Rescue would consent to such separation. Foster agrees that Indigo Rescue shall have the right to reclaim the animals if the animals have been separated without Indigo Rescue prior written approval.

IV. RECOVERY OF FOSTERED ANIMAL UPON BREACH a. Foster agrees that if Indigo Rescue should determine at any time that any of the provisions of this Agreement have not been fully complied with, or that the animal rightfully belongs to some other person, Foster will return the animal to Indigo Rescue upon demand. If Foster fails to return the animal on demand, Indigo Rescue shall have the right, without further notice or demand, to enter the premises where the animal may be and remove the animal without process of law. b. Foster will allow any investigator of Indigo Rescue to inspect the animal and its living environment and to take photographs and videotapes of the animal in its living environment and to remove the animal if the investigator, in his or her sole discretion is not satisfied with the conditions under which the animal is being kept or believes that the conditions of this Agreement are being violated. c. In the event Indigo Rescue is forced to enact its rights granted by Foster under Section IV (a) and/or (b), Adopter agrees to waive all claims for trespass or damage.

V. NO EXPRESS OR IMPLIED WARRANTY or his/her family for bodily injury or property damage, the indemnification provisions of Section VI (c) shall apply. f. In the event Foster returns the animal to Indigo Rescue for any reason, Foster will at no time assert any claim or demand against Indigo Rescue for any charges which may have been incurred in connection with the animal. g. Foster agrees to pay and reimburse Indigo Rescue for any and all legal fees and court costs it incurs in enforcing the terms and conditions of this Agreement.

VI. JURISDICTION This Agreement shall be governed by the laws of the State of Oregon or Washington, determined by location of adoption. Foster is fully aware that Indigo Rescue makes no guarantees whatsoever as to the health, temperament, breeding, mental disposition, and training of the animal being adopted. Foster acknowledges that this Agreement contains no express or implied warranties concerning the health of the animal, the breeding of the animal, or that the animal adopted by the Foster is fit for any particular purpose.

VII. WAIVER, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT a. Foster hereby fully and completely releases Indigo Rescue, its agents, servants, employees, officers, successor entities and other affiliated persons or entities, from any defects or illnesses the animal may have at the time of receipt of animal or may develop at a later date. b. Foster hereby fully and completely releases Indigo Rescue, its agents, servants, employees, officers, successor entities and other affiliated persons or entities, from any claim, cause of action, or other liability for any bodily injury or property damage which is caused by the animal and for which liability is sought from Foster. c. Foster hereby agrees to indemnify and hold harmless Indigo Rescue against any and all claims, causes of action, or other liabilities, whether brought in a court of law, arbitration, tribunal or other legal proceeding, for which a third party seeks to impose liability on either Foster or Indigo Rescue for bodily injury or property damage alleged to be caused by the animal adopted by Foster from Indigo Rescue. d. If Foster has other pets at home, Foster attests to the fact that all of Foster's animals are current on their animal vaccinations. Foster fully and completely releases Indigo Rescue, its agents, servants, employees, officers, successor entities or other affiliated persons or entities, from any claim, cause of action or liability for any illness Foster's or other animals may develop, even if any said illness may have been procured from the animal adopted from Indigo Rescue. e. Foster hereby waives any right of action against Indigo Rescue for bodily injury or property damage occasioned by Foster or his/her family alleged to have been caused by the animal adopted from Indigo Rescue. In the event a claim is made against Indigo Rescue seeking liability for damages occasioned by Foster

VIII. SEVERABILITY OF THIS AGREEMENT The doctrine of severability shall be applied. In the event that any term, provision or paragraph of this Agreement is or is declared illegal, void or unenforceable, this shall not affect or impair the other terms, provisions, or paragraphs of this Agreement. I do hereby state that I have read this Agreement and fully understand it, the representations and warranties of the parties, the rights and remedies of the parties, and that I do hereby agree to be bound by its terms.
