**Indigo Rescue Volunteer Agreement – Hold Harmless Waiver**

I, \_\_\_\_\_ hereby agree that I am providing volunteer services to Indigo Rescue, having been made fully aware of the risks involved. For purposes of this agreement, “volunteer services” includes, but is not limited to, animals care, feeding, cleaning of outdoor animal areas, stalls, kennels, moving animals, assisting with adoption or fundraising events and any other activity relating thereto and associated with Indigo Rescue. I fully understand and agree to assume all risks involved in any duties that I perform for Indigo Rescue in my volunteer capacity and I agree to hold Indigo Rescue harmless for any injury(s) which I might sustain during the course of my volunteer duties. I understand and agree that neither Indigo Rescue nor third party locations are responsible for any illness or injury caused by any animals that I come into contact with during my foster/volunteer work. I hereby release, waive, discharge and covenant not to hold responsible Indigo Rescue and its officers, agents, other volunteers, or employees from any and all liability, claims, demands, actions, including court costs and attorney fees, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me.

In the event I agree to foster or transport an Indigo Rescue animal, I agree to voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage of property owned by me, as a result of fostering or transporting said animal, whether caused by the negligence of Indigo Rescue, its officers, agents, other volunteers, servants, employees or otherwise. It is my express intent that this Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to hold responsible Indigo Rescue, its officers, agents, servants, or employees. I hereby further agree that this Hold Harmless Agreement shall be construed in accordance with the laws of the State of Oregon. In signing this agreement, I acknowledge and represent that I have read the foregoing Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same. All minors must be accompanied by a parent or guardian. Additional signatures are required below for minors.
